- 1 A written, *completed* membership application in a form and manner approved by the Board of Directors accompanied by the initiation fee is required on behalf of any person applying for membership in the Golden Gate Yacht Club (GGYC).
- 2 The completed application should be sent to:

- 3 After the application is received, the applicant(s) will be contacted to schedule an informational interview at the Club with the Membership Committee.
- 4 The application shall bear the signatures of one qualified sponsor and two qualified seconders. The sponsor and each seconder must be Regular or Life members in good standing for more than one year. (Qualified sponsor signatures may be obtained at the Membership Committee interview.)
- 5 Applicants for membership to the Club shall not be discriminated against on the basis of race, color, religion, age, ancestry, national origin, sex, political affiliation, sexual orientation, disability or any other grounds prohibited by law.
- 6 After the interview, the application will be forwarded to the Board of Directors and will be put to vote at the next scheduled Board of Directors meeting. The Board of Directors meets on the 2nd Wednesday of each month.
- 7 After the membership application is approved by the Board of Directors, the new member(s) will be notified in writing and will receive a membership packet containing the Club By-Laws, a Membership Directory, Membership Card(s), and GGYC stickers. The GGYC burgee will be distributed to new members at the monthly member meeting at which time the new member will also be introduced to the membership.

- Camaraderie with fellow sailors from around the Bay and beyond (boat ownership is not a prerequisite for membership).
- Bar Grill is available during hours of operation. Menu is seasonal and includes favorites such as Caesar salads and burgers.
- Overnight and day docking facilities for sail and power boats. Reservations for berths are required.
- Access to member only events.
- Reciprocal privileges to over 700 yacht clubs in the U.S. and abroad.
- Reciprocal privileges with the University Cub, the City Club of San Francisco and Marine's Memorial.
- Race activities such as YRA races, Friday Night Race Series, and Manuel Fagundes Seaweed Soup Regatta (mid-winters).
